ARTICLE IX - AMENDMENT

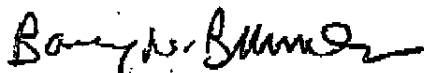

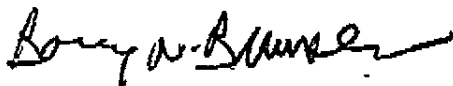
