## ARTICLES OF INCORPORATION OF SOHOM II, INC.

The undersigned, incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

### ARTICLE I: NAME OF THE CORPORATION
