

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is Company Times, Inc.

ARTICLE II

The existence of the corporation shall begin as of the date of filing these Articles.

ARTICLE III

The corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.


