ARTICLES OF INCORPORATION OF PALKO & ASSOCIATES, INC.

The undersigned, acting as incorporator of a corporation for profit under the Alabama General Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I.

NAME: The name of this corporation is PALKO & ASSOCIATES,
