The undersigned natural person, competent and licensed or otherwise legally authorized to practice in the State of Florida, acting as hereby incorporator for the purpose of forming a Professional Service Corporation for profit under the provisions of Section 607, Florida Business Corporation Act, of the Florida Statutes, does hereby adopt the following Articles of Incorporation:

Ι

Names of Corporation, Principal Office and Mailing Address

The name of this corporation shall be J.D. Lewis, IV, P.A.

Purposes

The general nature and purposes of business to be transacted, promoted and carried on by the corporation are as follows:
