

ARTICLES OF INCORPORATION 99 OCT -5 AM 10:38

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

1. Name. The name of this corporation is

2. Duration. This corporation shall commence its existence on the date of execution and acknowledgement of these Articles of Incorporation, and shall have perpetual existence unless sooner dissolved according to law.

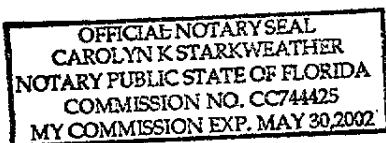
