#### **ARTICLES OF INCORPORATION**

The undersigned incorporator(s), being an individual duly licensed to render athletic medicine services, hereby form a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

#### ARTICLE I. CORPORATE NAME.
