The undersigned, for the purpose of forming a Corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

Article I - Name; Principal Office

The name of this Corporation shall be **EXPERT PLUMBING, INC.** (the "Corporation"). The street address and the mailing address of the initial principal office of the Corporation shall be Century Plaza, Suite 220, 135 W. Central Boulevard, Orlando, Florida 32801-2435, or such other place as may be designated by the Board of Directors.

Article II - Capital Stock

The Corporation shall have the authority to issue 10,000 shares of voting common stock, with a par value of \$1.00 per share.
