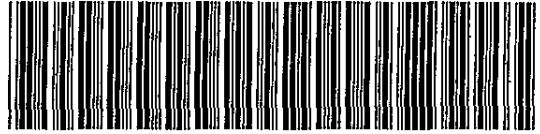

1. The following provisions of the Articles of Incorporation of Maria Price Interiors, Inc., a Florida corporation, be and they hereby are amended in the following particulars:


ARTICLE I is hereby amended to read as follows:
