**Articles of Incorporation
of
Kaplan Law Firm, PA**

The undersigned incorporator hereby executes these Articles of Incorporation in order to form a professional services corporation under the laws of Florida.

Article 1 - Name

The name of this corporation is Kaplan Law Firm, PA

Article 2 - Address

The street address and mailing address of the initial principal office corporation shall be 239 Easton Circle, Oviedo, Florida 32765.

Article 3 - Purpose

The corporation is a professional services corporation for the rendition of legal services pursuant to chapter 621, Florida Statutes. The nature of the business of the corporation shall be to render professional legal services to the public, and, in connection therewith, to perform all acts and provide all services which are normally and customarily performed and provided by attorneys-at-law admitted to practice in Florida. The corporation may own, mortgage, pledge, sell, assign, transfer, or otherwise dispose of, may invest in, trade in, deal in and with, products, goods, wares, and merchandise, real and personal property, and services of every kind, class, and description, and, in general, may conduct and transact any and all business activities to the extent not prohibited to a professional legal services corporation by the Florida Professional Services Corporation Act and other laws, rules, and regulations applicable to the corporation and its professional business.

Article 4 - Shares

The corporation is authorized to issue 1,000 shares of a single class of stock with par value of \$0.01 per share.

Article 5 - Incorporator

The corporation shall exist perpetually unless dissolved according to law.


