ARTICLES OF INCORPORATION OF ACADEMY OF PROFESSIONAL PROTECTION, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

Article I

The name of this Corporation shall be Academy of Professional Protection, Inc.

Article II

The principal place of business and mailing address of this Corporation shall be:

The general nature of the business to be transacted by this Corporation is any and all business permitted under the laws of the State of Florida.
