ARTICLES OF INCORPORATION

OF

U.S. CITY NETWORK, INC.

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I

NAME

The name of the corporation is U.S. CITY NETWORK, INC.

ARTICLE II

INITIAL PRINCIPAL PLACE OF BUSINESS

The street address of the initial principal place of business is 400 Patricia Drive, New Smyrna Beach, Florida 32168.

ARTICLE III

CAPITAL STOCK

The maximum number of shares of stock that the corporation is authorized to issue is One Million (1,000,000) shares of common stock having par value of \$1.00 per share. The consideration to be paid for each share shall be fixed by the Board of Directors. Common stock of the corporation shall be issued as "small business corporation" stock in accordance with a plan or plans under the provisions of Section 1244 of the Internal Revenue Code of 1954.





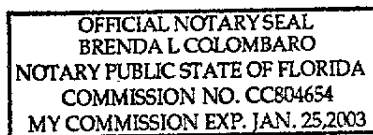
