# ARTICLES OF INCORPORATION OF BIG MOUTH UNIVERSAL COMMUNICATIONS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation:

#### ARTICLE I - NAME

The name of the corporation is:
