## ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incomparation, natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

## ARTICLE I. NAME

The name of the corporation is ALCEE IMPORTS, INC.

# ARTICLE II, NATURE OF BUSINESS

The general nature of business to be transacted by this corporation is any activity or business permitted under the laws of the United States and the State of Florida.

## ARTICLE III, CAPITAL STOCK
