**INTERDISCOS, INC.** (the "Corporation"), a corporation organized and existing under and by virtue of the Florida Business Corporation Act (the "FBCA"), and pursuant to the provisions of section 607.1006 of the FBCA, DOES HEREBY CERTIFY:

**FIRST:** The Certificate of Incorporation is hereby amended by changing Article Four to read as follows:

**FOURTH:** The aggregate number of shares which the Corporation shall have authority to issue is ONE MILLION FIVE HUNDRED THOUSAND (1,500,000), all of which are of NO PAR VALUE each and are of the same class and are to be Common Shares.

**SECOND:** The amendment to the articles of Incorporation of the Corporation set forth in this Articles of Amendment has been adopted on April 16, 2001 and it has been duly approved by the Shareholder's of the Corporation entitled to vote thereon, and the number of votes cast for the amendment were sufficient for approval in accordance with the applicable provisions of Chapter 607, Section 1003 of the Business Corporation Act of the State of Florida.
