

**ARTICLE I**

**NAME**

The name of this Corporation is D E RANCH, INC..

**ARTICLE II**

**PURPOSE**

This Corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE III**

**CAPITAL STOCK**
