ARTICLES OF INCORPORATION OF

ST. JOHN'S RIVER HYDROELECTRIC

The undersigned acting as incorporator of a corpora under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

- The name of the corporation is ST. JOHN'S RIVER HYDROELECTRIC AUTHORITY, INC.
 - The period of its duration is perpetual. II.
- III. The purpose of the corporation is to engage in any activities or business permitted under the laws of the United States, the State of Florida and in such other states as the corporation shall be authorized to do business.
- The aggregate number of shares which the corporation shall have authority to issue is 1,000 shares, all of one class, and having no par value.


