The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE 1: NAME

The name of the corporation shall be **CONSTRUCTION COST AND PROJECT MANAGEMENT, INC.**

ARTICLE 2: PURPOSE

The purposes of the corporation is to provide professional consulting services for construction cost and project management and any other lawful activity for which corporations may be organized under the laws of the United States, the State of Florida or any other state, country, territory or nation.

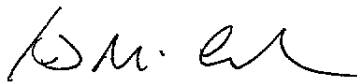

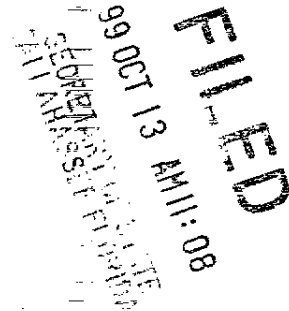
