The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following articles of incorporation.

ARTICLE I. NAME

The name of the corporation is Arieux Sprinklers, Inc.

ARTICLE II. PRINCIPAL OFFICE

The principal place of business of this corporation is 3300 North Folk Street, Mims, FL 32754 and the mailing address of this corporation is P.O. Box 6398, Titusville, FL 32782-6398.

ARTICLE III. NATURE OF BUSINESS

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE IV. CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 1000 shares of common stock having a par value of \$ 1.00 per share.

ARTICLE V. TERM OF EXISTENCE

This Corporation shall have perpetual existence commencing on date of filing.

ARTICLE VI. REGISTERED AGENT AND INITIAL REGISTERED OFFICE

ARTICLE IX. AMENDMENT





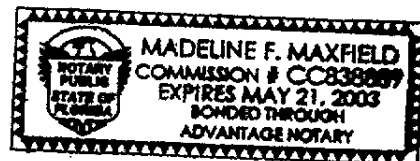
