

After answering my question, he then asked me why I am filing late, and incurring a penalty. I did not know that I was filing late, as I have no record of receiving an earlier notice. I had not carefully read the outside envelope on this mailing, which indicates that this is a second notice. He suggested I contact the Department of State and determine what I should do.

I called and spoke with a man named Steve, who instructed me to pay the original amount of \$150.00 and enclose a letter explaining that I would have paid the original fee had I known to do so.

This is my first year as a corporation, and I was not alert to this fee schedule. Steve instructed me to call again next March if I have not received a notice for 2001 by then. I will do so.

Regarding this year: If this request to accept the original fee of \$150.00 is not approved, please let me know quickly so that I can pay the \$400.00 penalty, rather than a higher one. Thank You.
