The name of the corporation shall be Southeast Property Data Services, Inc.

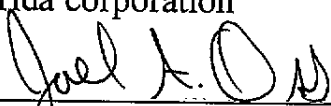
**ARTICLE II OF AMENDMENT**

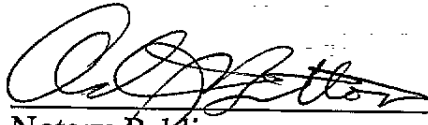
