

Article I - Name

The name of this corporation is Law Offices of Thomas C. Gano, P.A.

Article II - Duration

This corporation shall exist perpetually.

Article III - Purpose



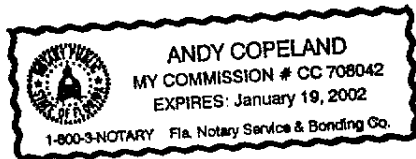


