ARTICLE I - NAME

The name of this Corporation is Still Strong Corporation and its address is 14090 S.W. 144 Avenue Road, Miami, Florida 33186.

ARTICLE II - DURATION

This Corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.

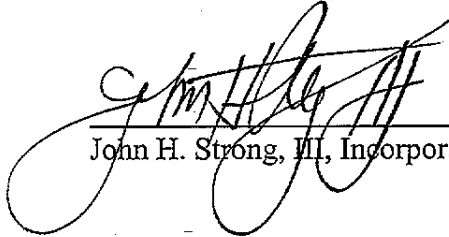
ARTICLE IX - INCORPORATOR

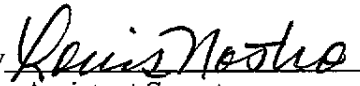
