#### ARTICLES OF INCORPORATION

ASECTION IN TO The undersigned subscribers to these Articles of Incorporation, natural persons of legal age and competent to contract, for the purpose of forming a corporation under the laws of the State of Florida, hereby adopt the following Articles of Incorporation.

- (c) The foregoing clauses shall be construed as both purposes and powers; and it is hereby expressly provided that the forgoing enumeration of specific powers shall not be held to limit or restrict in any manner the powers of the corporation.
