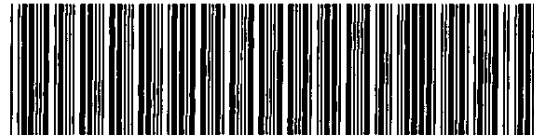

Dissolution of the corporation was approved and authorized on JUNE 1, 2006.


**ARTICLE III. APPROVAL OF DISSOLUTION**
