**ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME AND ADDRESS: The name of the corporation is BENTLEY OF SARASOTA, INC., and its mailing address is 1832 Cottonwood Trail, Sarasota, Florida 34232.

ARTICLE II

DURATION: The corporation shall exist perpetually.

ARTICLE III
