To Whom It May Concern:

This letter is in reference to the filing of the 2000 Uniform Business Reports (UBRS). I would like to explain why I did not succeed in getting these forms and the appropriate payments to you within the proper time frame. I would also be greatly appreciative if you could take into consideration all the reasons that brought about this situation.

This is the first experience I have had with owning and operating a corporation. As I did not receive my original forms, I had no idea that anything of this sort needed to be dealt with and filed, let alone by a particular date. The person who is kind enough to assist me and would have taken care of this matter was out of the country at the time. Unfortunately he didn't inform me until after his return about these forms that needed to be filled out and sent in with the payments. When I was informed of this requirement, I telephoned your office and explained my situation to someone on your staff named Ms. Wendy Hutchins, who was very understanding about everything, and took the time to explain precisely what was needed to clear up the problem. Ms. Hutchins was kind enough to wish me well, and mail the proper forms to me.

In addition to this, I have been extremely ill for months. For all intents and purposes, except for going to various doctors and taking care of the most basic necessities, I have essentially been housebound. During the last month I was scheduled to have an operation on two particular dates, each of which had to be postponed because of other medical problems that arose and further complicated this already difficult situation.

Over and above all of this, I live alone with my elderly mother for whom I am the primary caregiver. Recently, she too has had some problems, which, of course, also needed to be addressed. All in all, I have been struggling to do the best I could under this over abundance of adverse circumstances.
