**I**

The Name of the corporation shall be REGIONAL REFERRAL REGISTRY, INC. whose principal office shall be located at 1103 Mimosa Drive, Tallahassee, Florida 32312.

**II**

The duration of the corporation shall be perpetual.

**III**

The purpose for which the corporation is organized is to sell residential real property. The business may engage in any activity or business as permitted under the laws of the United States and under the laws of the State of Florida.

**IV**

The corporation shall consist of 100 authorized shares of stock with a par value of \$1.00.




