AMENDMENT TO THE ARTICLES OF INCORPORATION OF

SCHRAMM & COMPANY, P.A.

ARTICLE I

ARTICLE I is hereby amended to read as follows:

As there presently exists only one shareholder of the issued and outstanding shares of the Corporation, the Corporation shall exchange the certificate of the said shareholder for a certificate representing an identical number of shares which properly reflects the name change of the Corporation and cause the shares taken in to be cancelled.

This Amendment to the Articles of Incorporation was adopted by the shareholders and directors on the 1st day of November, 1999.
