We, the undersigned, hereby make, subscribe, acknowledge and file these Articles of \_\_\_\_\_  
Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

**ARTICLE I**

The name of the corporation shall be:

**THE STATION OF ORMOND BEACH, INC.**

**ARTICLE II**

This corporation may engage in any activity or business permitted under the laws of the United  
States and permitted under the laws of the State of Florida, including but not limited to:

Pressure cleaning commercial and residential. Any type of construction, development or sale of  
real or personal property herein the State of Florida; as well as all business activities related thereto, or  
which may be necessary, advantageous or proper in the conduct of the business; to exercise generally such  
powers as may be incidental to or convenient for the purposes and business of the corporation; and to have,  
exercise and enjoy all the rights and privileges of a corporation for profit under the laws of the State of  
Florida; it being expressly provided that the foregoing enumerated powers shall not be held to limit or  
restrict the general powers of the corporation.

### **ARTICLE III**

The maximum number of shares of stock this corporation may issue is one thousand shares of common stock, which shall be the common stock of \$1.00 par value. All said common stock shall be payable in cash, or payable by property, labor or services at a just valuation by the stockholders. Property, labor or services may be purchased or paid for with capital stock at a just valuation fixed by the stockholders.


## ARTICLE IX
