Dear Madam or Sir:

We have enclosed a Reinstatement form for Weinstein Dialysis, Inc. along with a check made payable to the Florida Department of State in the amount of \$450. Because the corporation was administratively dissolved on September 21, 2001, the enclosed check covers the annual report fees for the years 2001, 2002, and 2003. This does not include the reinstatement fee because we are requesting a waiver.

We are requesting a waiver of the reinstatement fee of \$600 because it has come to our attention that in 2000 the Department of State incorrectly entered a change of address for Weinstein Dialysis, Inc. into its databases. After the year 2000 Weinstein Dialysis, Inc. never received any Uniform Business Reports ("UBR") or any notice of administrative dissolution from the Department of State because these appear to have been sent to the wrong address. (Note that the street address listed by Weinstein Dialysis, Inc. on its UBR for 2000 was "5307 E. Fletcher Ave." but the Department lists "5309 E. Fletcher Ave." on the Sunbiz website.) Even though Weinstein Dialysis, Inc. never received the UBRs and the notice, the Department administratively dissolved the corporation for failure to file annual reports. Department representatives have advised me by telephone that the reinstatement fee would be waived under these circumstances and we also rely on Section 607.1421(1) of the Florida Business Corporation Act.

Please reinstate Weinstein Dialysis, Inc. to active status at the address listed on the Reinstatement form.
