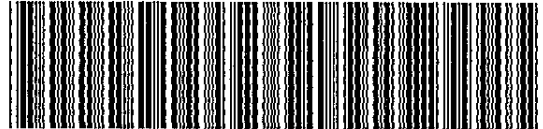

COPPERHEAD GOLF CLUB, INC.

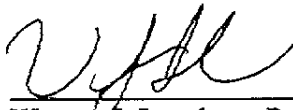
Pursuant to Section 607.1403, Florida Statutes, this Florida profit corporation submits the following Articles of Dissolution:
