ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF CARE 1.COM, CORP. OO FEB 24 PH 2: 36
PALLAHASSEE, FLORIDA

CARE 1.COM, CORP., a corporation for profit organized and existing under the laws of State of Florida (the "Corporation"), in order to amend its Articles of Incorporation in accordance with the requirements of Chapter 607, Florida Statutes, does hereby certify as follows:

- 1. The Articles of Incorporation of the Corporation were filed by the Secretary of State of the State of Florida on October 18, 1999.
- 2. The amendment to the Articles of Incorporation being effected hereby will completely delete ARTICLE 3, subparagraph 1. of the Articles of Incorporation as of the date hereof, and substitute in its place the ARTICLE 1 set forth below. As amended below, ARTICLE 1 of the Articles of Incorporation has the sole effect of changing the Corporation's authorized capitalization from 1,000 shares of common stock, par value \$.001 per share (the "Common Stock") to 100,000,000 shares of common stock, par value \$.001 per share (the "Common Stock.")

ARTICLE 3

CAPITAL STOCK

1. <u>Authorized Capitalization</u>. The total number of shares of capital stock authorized to be issued by this Corporation shall be:

100,000,000 shares of common stock, par value \$.001 per share (the "Common Stock").
