The undersigned incorporator, for the purpose of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation for such corporation:

- 1. NAME. The name of the corporation is GulfScript, Inc.
- 2. **PRINCIPAL OFFICE**. The street address of the initial principal office of the corporation is:

3. CAPITALIZATION.

- (a) Authorized shares. The aggregate number of shares which the Corporation shall have authority to issue is Four Million (4,000,000), of which Two Million (2,000,000) shares with par value of One Dollar (\$1.00) each shall be designated "Class A Shares" and Two Million (2,000,000) shares with par value of One Dollar (\$1.00) each shall be designated "Class B Shares."
- (b) Relative rights and preferences. - (c) Preemptive rights denied. No holder of any shares of the Corporation shall have any preemptive right to purchase, subscribe for, or otherwise acquire any shares of the Corporation of any class now or hereafter authorized, or any securities exchangeable for or convertible into such shares, or any warrants or other instruments evidencing rights or options to subscribe for, purchase or otherwise acquire such shares.


