To Whom It May Concern:

I very recently learned that the above corporation, of which I am the principal officer, has been administratively dissolved for failure to file an annual report. This is the first Florida Corporation with which I've been associated, and because I had never received notification that an annual report was due, I inquired with your offices about why that was so. When I did, I discovered that the corporation's address is incorrectly shown to be "5845 "C" Hollywood, Florida 33021," with the street name, "Hollywood Blvd.," (after the "C") missing.

It appears that the above occurred because the street name had been inadvertently omitted in a single place in the corporation's Articles of Incorporation. In every other place in the Articles of Incorporation, the correct address is shown, as is the address of the initial registered office, and the name and address of the registered agent. It seems likely that notification was sent to the incorrectly truncated address and was returned undeliverable.

I apologize for the error made in drafting the Articles of Incorporation and have enclosed amended articles and a completed Corporation Reinstatement form (both showing the correct address). I've also enclosed a check for \$300.00 and am respectfully requesting that any greater reinstatement fees be waived in this case.
