Article III Capital Stock. There shall be Authorized One Hundred Million Shares of Common Stock at a Par Value of \$0.001 per share.


**Second:** All of the Amendments were approved by the shareholders on October 25, 1999. The number of vote cast for the Amendment was sufficient for approval.
