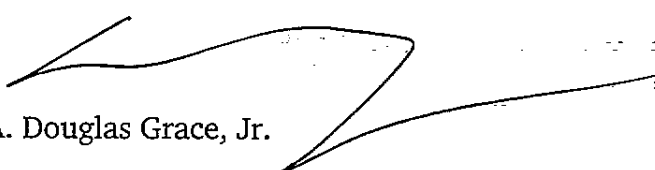

I, the undersigned, hereby associate myself for the purpose of forming a corporation under the laws of the State of Florida under the corporate name of JZ & RL CORPORATION, INC., and hereby set forth and declare:

**ARTICLE I  
NAME OF CORPORATION**

The name of the corporation shall be JZ & RL CORPORATION, INC.

**ARTICLE II  
EXISTENCE**

This corporation shall exist perpetually unless dissolved according to law.

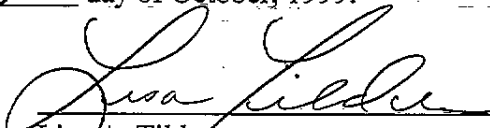
ARTICLE VIII

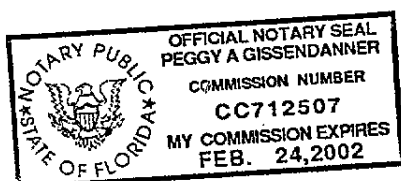

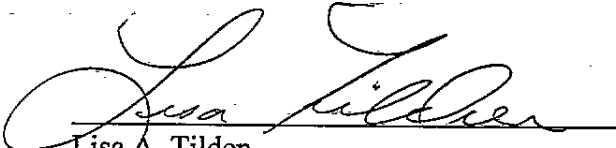

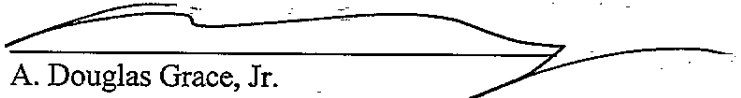
