

## Rhinestone, Inc.

The undersigned incorporator(s) for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt(s) the following Articles of Incorporation:

## ARTICLE 1

### **NAME**

The name of the corporation shall be **Rhinestone**, **Inc.** The principal place of business of this corporation shall be as follows:

## TERM OF EXISTENCE
