Articles Of Incorporation Of P C Made Easy, Inc.



The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

Article I

The name and mailing address of the corporation is **P C Made Easy, Inc.**, P.O. Box 18305, Panama City Beach, FL 32417-8305

Article II

The period of duration is perpetual.

Article III

The purpose is to engage in any activities or business permitted under the laws of the United States and the State of Florida.

Article IV

The corporation shall have the authority to issue 1,500 shares of common stock having a par value of \$1.00 per share.

Article V

The number of directors may be from time to time fixed by the shareholders. The number of directors constituting its initial Board of Directors are three (3) Directors whose name and address are as follows:

Article IX


