**ARTICLES OF INCORPORATION**  
**OF**  
**FORTUNE OUTDOOR ADVERTISING, INC.**

**ARTICLE I - NAME AND ADDRESS**

The name of the Corporation shall be **FORTUNE OUTDOOR ADVERTISING, INC.** with its principal place of business at 138 Bushnell Plaza, Suite 300, Bushnell, Florida 33513.

**ARTICLE II - NATURE OF BUSINESS**

This Corporation may engage or transact in any or all lawful activities or business permitted under the Laws of the United States of America, the State of Florida, or any other state, territory, country, or nation.

**ARTICLE III - CAPITAL STOCK**

**ARTICLE VIII - BY-LAWS**


