# ARTICLES OF INCORPORATION OF

### <u>ARTICLE I - NAME AND BUSINESS ADDRESS</u>

The name of this Corporation is Buddy's Liquors, Inc. Its principal office and mailing address is 550 Washington Avenue, Miami Beach, Florida 33139.

#### **ARTICLE II - DURATION**

The effective date of this Corporation shall be October 8, 1999, and it shall exist perpetually thereafter unless sooner dissolved according to law.

#### ARTICLE III - PURPOSE
