ARTICLES OF INCORPORATION

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I-NAME

The name of the corporation shall be: BIZZY "Bs", Inc., hereafter referred to as the corporation. The corporation is an entity engaged in commercial, residential, and industrial cleaning, etc. pursuant to all Florida Statutes pertaining to such activity.
