# ARTICLES OF INCORPORATION OF MILLENNIUM STYLE, INC.

# ARTICLE I - NAME

The name of this corporation is MILLENNIUM STYLE, INC.

# ARTICLE II - DURATION

This corporation shall have perpetual existence, commencing upon the filing of the Articles of Incorporation with the Secretary of the State of Florida.

# ARTICLE III - PURPOSE

The purpose of this corporation is to engage in transacting any and all lawful business for which corporations may be incorporated under Chapter 607 of the Florida Statutes.

# ARTICLE IV - CAPITAL STOCK

ARTICLE IX - INCORPORATORS AND SUBSCRIBERS

This right may also be waived by affirmative written waiver submitted by the shareholder to the Corporation within thirty (30) days of receipt of notice from the Corporation.


