

OF

ARTICLE ONE. NAME

The name of the corporation is BEAU VERRE, INC.


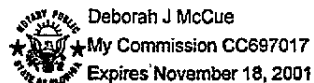
