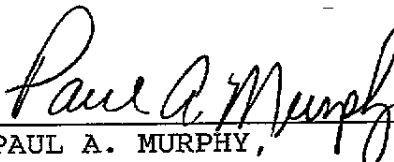

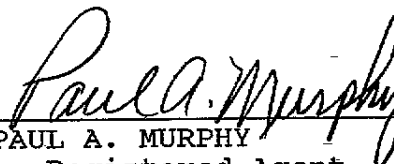
ARTICLE IX

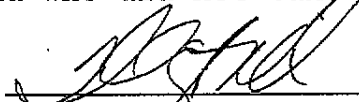


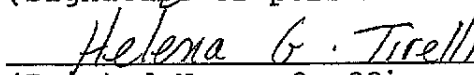

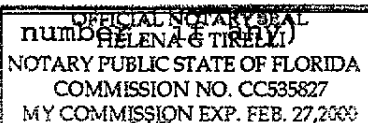
