

**ARTICLES OF INCORPORATION

**PRESCRIPTION-WORLD, INC.**

**ARTICLE I - NAME**

The name of this corporation is PRESCRIPTION-WORLD, INC., (hereinafter "Corporation").

**ARTICLE II - DURATION**

This Corporation shall exist perpetually, commencing on the date of filing of these Articles of Incorporation.

**ARTICLE III - PURPOSE**

This Corporation is organized for the following purposes: To engage in all facets of the medical and pharmaceutical businesses, and to do all or anything connected therewith or incidental thereto in connection with the foregoing, and for the purpose of transacting any or all lawful businesses of any kind or description permitted by law.

**ARTICLE IV - CAPITAL STOCK**

This Corporation is authorized to issue 5,000 shares of one-tenth of one cent (\$.001) par value common stock, which shall be designated "Common Shares".

**ARTICLE V - PREEMPTIVE RIGHTS**

Every shareholder, upon the sale for cash of any new stock of this Corporation of the same kind, class or series as that which the shareholder already holds, shall have the right to purchase a pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.
