The undersigned, being duly licensed to practice law in the State of Florida, desiring to form a corporation in accordance with Chapter 621 of the Professional Service Corporation and Limited Liability Company Act, adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

1.01 The name of the Corporation shall be Law Office of Burt Alvarez, P.A.

ARTICLE TWO

REGISTERED OFFICE AND AGENT

8.01 The amount of capital with which the Corporation shall begin business is Five Hundred Dollars (\$500.00).

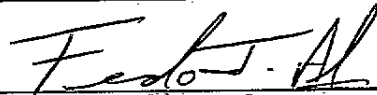
## ARTICLE NINE

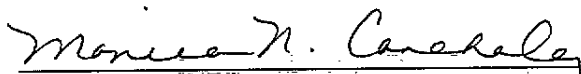

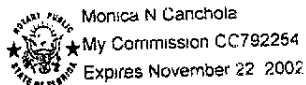

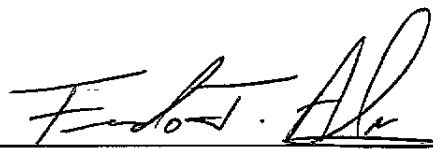
