ARTICLE I

NAME

The name of the corporation is CONSOLIDATED MANAGEMENT RESOURCES, INC. The mailing address of the corporation shall c/o One S.E. Third Avenue, Suite 1940, Miami, Florida 33131.

ARTICLE II

DURATION

This corporation shall have a perpetual existence commencing upon filing of the Articles of Incorporation with the Secretary of State.


ARTICLE VII

INITIAL REGISTERED OFFICE AND AGENT


