#### ARTICLES OF INCORPORATION

The undersigned, acting as an incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is JOEMIA The initial street address of the principal office of this corporation in the State of Florida is 2724 N. Andrews Avenue, Wilton Manors, Florida 33311. The Board of Directors may from time to time move the principle office to any other address in Florida.

SECOND: The period of duration of the corporation is perpetual.
