**INFOQUEST SOLUTIONS, INC.
PLAN OF LIQUIDATION AND DISSOLUTION**

1. The officers are authorized to sell any or all of the assets, if any, of the Corporation for such prices and on such terms as the officers deem appropriate.
2. The officers shall wind up the affairs of the Corporation, shall collect its assets, shall pay or provide for its liabilities and shall establish a reserve (if deemed appropriate) to meet known liabilities and liquidating expenses and estimated unascertained or contingent liabilities and contingent expenses.
3. The officers shall distribute the remaining assets of the Corporation (subject to any remaining liabilities) to the shareholders in exchange for their shares.
4. The officers are authorized to take such actions as they deem appropriate to carry out the terms of this plan, including the signing and delivery of deeds, assignments and other documents.
5. After completing the liquidation, the officers shall take all actions necessary to terminate the existence of the Corporation.
